This fiscal year was shortened to 6 months as we moved to align our year with that of AV. At the end of the shortened 2024 financial year, the club membership stood at 75 (including life members) down from 94 at the end of the prior year.

Our new financial year has enabled us to adopt the AV registration system. This has simplified our process for registering members, communicating with them, and ensuring that all members are covered by AV insurance.

With the shorter year, there is a bit less to report. We had successful end of year events including the annual dinner and pre-Christmas breakfast.

We have started experimenting with occasional ParkRun get-togethers. A late January meeting at Princes Park was well attended (c 20).

Weekday sessions continue to attract a core group of members and occasionally new comers or out of town visitors. We are seeing some renewed interest in the club thanks to coverage in local press and perhaps the general running (and running group) boom. We are midway through the championship series having held the 2km in the rain earlier today.

We have started a review of our website and social media presence to try to improve visibility of the club to new members. Rob and Shane have been engaging with their younger family members.

Thanks to Mike Bialczak for his handicapping and regular Park Run reports from Mike Bialczak.

Thanks to Rob in the role as training programmer and to Dale Nardella for complaints handling.

Thanks to Ingrid Morrison stepping up as Treasurer and to Mark Willets as Secretary. And thanks to the rest of the committee: Nick, Greg, Michael, Anne, Rob, and Shane.
